The Kingfisher Solar project had been discussed.

The Ward Councillor explained that the organisation, East Riding Against Solar Expansion (ERASE), is up and running.

The Ward Councillor has meetings with the Mayoral Candidate and ERYC Rural Partnership next month and will raise the issue of the Kingfisher Solar project.

There had been a serious accident at Kiplingcotes where a dog had fallen from the bridge and sustained serious injuries; the PC felt that this was a Health & Safety risk and asked the Ward Councillor to follow up with ERYC.

ERYC had carried out highway repairs in the Parish, and the PC felt this work was not done to the required standard—the Ward Councillor to follow up with ERYC highways.
